What is a UCC?

Commercial transactions are governed by laws and when all the 50 states adopt the same “uniform” law for commercial transactions, they are known as *Uniform Commercial Code*. Essentially, the UCC is just a huge list of laws. But the aspect of the UCC we’ll be discussing—and what your business needs to know about—is Article 1: General Provisions, which dictates UCC-1 Filings, more commonly referred to as UCC filings.

What Is a UCC Filing?

UCC filings or **liens** are legal forms that a creditor files to give notice that it has an interest in the personal or business property of a debtor. Essentially, UCC lien filings allow a lender to formally lay claim to collateral that a debtor pledges to secure their financing. The term is a part of a collection of rules established to regulate how commercial transactions work under the Uniform Commercial Code (UCC).
